#### **Initiative A-Increase CTAE awareness**

# Initiative B-Raise industry certification

- Action Step a- Seek industry certification for all CTAE Programs.
- Action Step b- Teachers will participate in professional development opportunities to prepare for industry certification which is a two-year process.

Initiative C-Increased number of Pathway completers and students passing End of Pathway Assessments

- Action Step a- Continue to track students and work with scheduling to ensure courses are available and students are enrolled in appropriate courses.
- Action Step b- Prepare students for End of Pathway Assessments (tutoring, purchasing available study guides, etc.).
- Action Step c- Explore expanding the number of dual enrollment courses in the CTAE Department.

# Performance Objective 4-Increase the integration of technology in instruction.

Initiative A-Provide instructional and technical support to each school to help classroom teachers increase and utilize technology successfully.

- Action Step a- Teacher utilization of computerized technology maintenance requests
- Action Step b- Offer local instructional technology courses based on identified needs. (Partner with RESA)
- Action Step c- Focus software investments on curriculum aligned online resources (Study Island, IXL, Progress Learning, etc.).
- Action Step d- Utilize student information system (SLDS) for student and teacher learning resources.
- Action Step e- Explore training for teachers to utilize technology more effectively in teaching lessons.
- Action Step f- Offer Computer Science Endorsements for middle and high school teachers.
- Action Step g Addition of an Information Technology Support Specialist (49%) – SY '21-22

Initiative B-Provide technology instruction and support for parents and students.

- Action Step a- Increase awareness and provide training on the use of Parent Portal and Student Portal.
- Action Step b- Continue to provide students with an electronic device to manage their documents, digital resources, activities, and time.

Performance Objective 1-Implement instructional training and support for faculty and staff.

Initiative A-Provide training for faculty and staff.

- Action Step e- To prepare for the implementation of SB 108 regarding technology courses, the high school and each middle school will provide at least one teacher the opportunity to secure a Technology Endorsement prior to the 2022-2023 school year. (completed SY '23)

- Action Step e- Continue to increase school branding School Spotlight Showcase added SY '20-21 at monthly board meetings.
